THE CARIBBEAN COMMUNITY (CARICOM) DOMINICAN  
REPUBLIC FREE TRADE (AMENDMENT TO THE  
SCHEDULE) ORDER, 2004

1. This Order may be cited as the Caribbean Community (CARICOM) Dominican Republic Free Trade (Amendment to the Schedule) Order, 2004.

2. Attachment III to the Protocol in the Schedule to the Caribbean Community (CARICOM) Dominican Republic Free Trade Act, 2001 is amended—

(a) in Chapter 18—

- (i) in relation to the goods carrying the tariff heading number "1806.31" and the description "Blocks, slabs or bars, filled", by deleting the words under the heading "Criteria" and substituting the following:

"Production in which all the non-originating materials used are classified in Headings of the Harmonized Commodity Description and Coding System different from that of this Heading except Chapter 17 and Headings 18.01 to 18.05"; and

- (ii) in relation to the goods carrying the tariff heading number "1806.32" and the description "Blocks, slabs or bars, not filled", by deleting the words under the heading "Criteria" and substituting the following:

"Production in which all the non-originating materials used are classified in Headings of the Harmonized Commodity Description and Coding System different from that of this Heading except Chapter 17 and Headings 18.01 to 18.05";

(b) in Chapter 84, by deleting the paragraph commencing with the words "In accordance" and ending with the words "Rules of Origin," and substituting the following Table:

Tariff Heading No.	Description	Criteria
84.15	Air-conditioning machines, comprising a motor-driven fan and elements for changing the temperature and humidity, including those machines in which the humidity cannot be separately regulated.	Production from non-originating materials of any sub-heading other than 8415.90
84.18	Refrigerators, freezers and other refrigerating or freezing equipment electric or other; heat pumps other than air-conditioning machines of headings 84.15	Production from non-originating materials of any sub-heading other than 8418.91 and 8418.99;

and

(c) in Chapter 85, by deleting the paragraph commencing with the words "In accordance" and ending with the words "Rules of Origin," and substituting the following Table:

Tariff Heading No.	Description	Criteria
85.06	Primary cells and primary batteries	Production from non-originating materials of any sub-heading
8507.10	Lead acid, of a kind used for starting piston engines	Production from non-originating materials of any sub-heading.
