MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(HOSEIN) ORDER, 2006

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Hosein) Order, 2006.
2. This Order shall have effect from—
  - (a) 10.00 p.m. on Tuesday 7th February, 2006 to 4.00 a.m. on Wednesday 8th February, 2006;
  - (b) 10.00 p.m. on Wednesday 8th February, 2006 to 4.00 a.m. on Thursday 9th February, 2006;
  - (c) 10.00 p.m. on Thursday 9th February, 2006 to 4.00 a.m. on Friday 10th February, 2006; and
  - (d) 10.00 a.m. to 7.00 p.m. on Friday 10th February, 2006.
3. On the dates and during the times specified in clause 2, vehicular traffic is prohibited on the Western Main Road, between Long Circular Road and George Cabral Street.
4. On the dates and during the times specified in clause 2, parking is prohibited on—
  - (a) Nepal Street, between the Western Main Road and Hyderabad Street;
  - (b) Clarence Street, between the Western Main Road and Anderson Street;
  - (c) Dengue Street, between the Western Main Road and Anderson Street;
  - (d) Ethel Street, between the Western Main Road and Finland Street;
  - (e) Lazare Street, between the Western Main Road and Carlton Avenue;
  - (f) Romeo Street, between the Western Main Road and Carlton Avenue;
  - (g) Mathura Street, between the Western Main Road and Carlton Avenue;

- (h) Long Circular Road, between the Western Main Road and Barbados Road;
- (i) Bengal Street, between the Western Main Road and Delhi Street;
- (j) Agra Street, between the Western Main Road and Delhi Street;
- (k) Madras Street, between the Western Main Road and Delhi Street;
- (l) Calcutta Street, between the Western Main Road and Delhi Street;
- (m) Bombay Street, between the Western Main Road and Church Street;
- (n) Mooneram Street, between the Western Main Road and Church Street;
- (o) Brunton Road, between the Western Main Road and Church Street;
- (p) Bournes Road, between the Western Main Road and Church Street;
- (q) Jerry Street, between the Western Main Road and Church Street; and
- (r) Salazar Street, between the Western Main Road and Church Street.

Parking prohibited 5. Parking is prohibited on Friday 10th February, 2006 from 10.00 a.m. to 8.00 p.m. on—

- (a) Vidale Street, between the Western Main Road and Anderson Street;
- (b) Nizam Street, between Hyderabad Street and the Western Main Road;
- (c) George Cabral Street, between Kathleen Street and the Western Main Road;
- (d) Cawnpore Street, between Hyderabad Street and the Western Main Road;
- (e) Kathleen Street; and
- (f) Delhi Street.

Removal and impounding of vehicles unlawfully parked

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
