THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(ST. JAMES, SAN FERNANDO AND TUNAPUNA
CHILDREN'S CARNIVAL PARADE OF BANDS) ORDER, 2006

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (St. James, San Fernando and Tunapuna Children's Carnival Parade of Bands) Order, 2006.
2. This Order shall have effect on the following times and dates:

	Duration
(a) from 12.00 midday to 7.00 p.m. on Sunday 19th February, 2006, in St. James;	
(b) from 9.00 a.m. to 6.00 p.m. on Sunday 26th February, 2006, in San Fernando; and	
(c) from 1.00 a.m. to 9.00 p.m. on Sunday 26th February, 2006, in Tunapuna.	

PART I
ST. JAMES

3. Parking and vehicular traffic are prohibited on the Western Main Road, between Roxy Roundabout and George Cabral Street.

Road closed parking prohibited

4. Vehicle traffic along the Western Main Road—

Vehicular traffic diverted

 - (a) proceeding west, shall be diverted south onto Damian Street and onto Mucurapo Road;
 - (b) proceeding east, shall be diverted north onto George Cabral street, east onto Kathleen Street, then onto Delhi Street and onto Barbados Road.
5. Parking is prohibited on the following roads:
 - (a) Damian Street;
 - (b) George Cabral Street;
 - (c) Kathleen Street; and
 - (d) Delhi Street.

6. Vehicular traffic is prohibited on the following roads:

- (a) Salazar Street;
- (b) Jerry Street;
- (c) Bournes Street;
- (d) Brunton Road;
- (e) Mooneram Street;
- (f) Bombay Street;
- (g) from Church Street in a southerly direction on—
 - (i) Calcutta Street;
 - (ii) Madras Street;
 - (iii) Agra Street; and
 - (iv) Bengal Street;
- (h) from Delhi Street in a southerly direction on—
 - (i) Luckput Street;
 - (ii) Mathura Street;
 - (iii) Romeo Street; and
 - (iv) Lazare Street;
- (i) from Carlton Avenue in a southerly direction on Ethel Street;
- (j) from Bay Road in a northerly direction on—
 - (i) Dengue Street;
 - (ii) Vidale Street;
 - (iii) Clarence Street; and
 - (iv) Nizam Street;
- (k) from Anderson Street in a northerly direction on—
 - (i) Nepal Street;
 - (ii) Cawnpore Street;
 - (iii) Benares Street;
 - (iv) Lucknow Street; and
- (l) from Hyderabad Street in a northerly direction, Ganges Street in a northerly direction.

PART II

SAN FERNANDO

7. Parking and vehicular traffic are prohibited on—
- (a) Royal Road;
 - (b) Coffee Street; and
 - (c) Cipero Street.
8. Vehicular traffic proceeding west along Naparima-Mayaro Road, shall turn right onto Circular Road. Road closed
parking
prohibited
9. Vehicular traffic proceeding west along Navet Road, shall turn left onto Bertrand Street. Right turn
only

PART III

TUNAPUNA

10. Parking and Vehicular traffic are prohibited on the Eastern Main Road, between Macoya Road and Cochrane Street. Road closed
parking
prohibited
11. Vehicular traffic along the Eastern Main Road—
- (a) proceeding east, shall be diverted north onto Tunapuna Road, east onto Green Street, south onto El Dorado Road and east onto the Eastern Main Road; and
 - (b) proceeding west, shall be diverted north onto El Dorado Road, west onto Green Street, south onto Fairley Street, west onto Sheriff Street, south onto Tunapuna Road and west along the Eastern Main Road. Vehicular
traffic
diverted
12. Parking is prohibited on the following roads: Parking
prohibited
- (a) Tunapuna Road, between the Eastern Main Road and Green Street;
 - (b) Green Street, between Tunapuna Road and El Dorado Road;
 - (c) Sheriff Street, between Fairley Street and Tunapuna Road; and
 - (d) the Eastern Main Road, between Tunapuna Road and El Dorado Road and Macoya Extension.

13. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
