MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SIPARIA KI MAI CELEBRATIONS) ORDER, 2007

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Siparia Ki Mai Celebrations) Order, 2007. Citation

2. This Order has effect from 3.00 p.m. on Thursday 5th April, 2007 to 12.00 noon on Friday 6th April, 2007. Duration

3. Vehicular traffic and parking are prohibited on—

- (a) George Street, between Edward Street and La Pastora Street;
- (b) Mary Street, between Edward Street and La Pastora Street; and
- (c) La Pastora Street, between Victoria Street and Siparia-Erin Road.

Vehicular traffic and parking prohibited

4. Parking is prohibited on the following:

- (a) De Gannes Lane;
- (b) Victoria Street, between Coora Road and La Pastora Street;
- (c) Siparia Road, between Potter Lane and Siparia-Erin Road;
- (d) Edward Street, between Mary Street and Siparia-Erin Road;
- (e) Coora Road, between Mary Street and Siparia-Erin Road; and
- (f) Mary Street, between Station Street and Coora Road.

Parking prohibited

5. (1) Between the hours of 6:00 p.m. on Thursday, 5th April, 2007 and 12:00 noon on Friday, 6th April, 2007— Traffic routes

- (a) vehicular traffic shall proceed in a westerly direction along the Siparia-Erin Road, between Edward Street and La Pastora Street;

- (b) vehicular traffic approaching Siparia from Erin along Siparia-Erin Road, proceeding towards San Fernando, shall proceed north onto Siparia Old Road, east onto Gambal Street, onto Grell Street and east onto Siparia-Erin Road; and
- (c) vehicular traffic approaching Siparia from Fyzabad along Siparia Old Road, shall proceed east onto De Gannes Lane, south onto Coora Road and east or west onto Siparia-Erin Road.

Removal and
impounding
of vehicles
unlawfully

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
